



## Privacy Policy

### 1. Who We Are

We are the data controller responsible for your personal information.

### 2. Information We Collect

We may collect the following information when you use our website or place an order:

- **Identity & Contact Data:** name, billing/delivery address, email address, telephone number
- **Transaction Data:** purchase history, order details, payment confirmations
- **Technical Data:** IP address, browser type, device information
- **Usage Data:** how you use our website (pages visited, products viewed)

We do **not** collect or store your payment card details. All payments are processed securely through **PayPal**.

### 3. How We Use Your Information

We use your personal data for:

- Processing and fulfilling your orders
- Delivering products to your chosen address
- Communicating with you regarding your order or customer support enquiries
- Meeting our legal and accounting obligations
- Improving our website and services

We will only use your information where we have a lawful basis to do so (e.g., contract, legal obligation, legitimate interests, or your consent).

#### 4. Sharing Your Information

We may share your information with:

- **Service providers** (e.g., delivery companies, IT support)
- **Payment provider** (PayPal) for secure transactions
- **Regulatory authorities** if required by law

We will never sell or rent your personal information to third parties.

#### 5. Data Retention

We retain your personal data only as long as necessary for the purposes outlined in this policy, typically:

- Order records: **6 years** (for tax and legal compliance)
  - Customer account details: until you request deletion
- 

#### 6. Data Security

We use appropriate technical and organisational measures to protect your data against loss, misuse, or unauthorised access.

#### 7. Your Rights

Under UK GDPR, you have the right to:

- Access the personal data we hold about you
- Request correction of inaccurate data
- Request deletion of your data (where legally permissible)
- Object to processing for direct marketing
- Request transfer of your data to another service provider
- Lodge a complaint with the **Information Commissioner's Office (ICO)**
